

What to expect... and what we expect from you.



What We Offer:

- A specialised bereavement support service for children aged 5-16 years
- An initial clinical assessment conducted by a qualified assessor with the pupil and/or parent
- An initial offer of 6-12 weekly sessions lasting 45-60 minutes held at the same time and place with the same support worker
- Sessions held at school or at our consulting rooms in central St Albans
- A safe, non-judgmental and non-denominational service



Our Self-Referral Fee Policy:

- Initial one-off clinical assessment is charged at £30 or £15 per session for those on means-tested benefits
- Weekly counselling sessions are subsidised and charged at £30 or £15 per session for those on means-tested benefits
- Payment will be made weekly after each session by cash or cheque made payable to 'St Albans Bereavement Network'
- Missed or cancelled sessions are chargeable in full, apart from exceptional circumstances (such as prolonged illness or hospital admissions) to enable a space to be reserved weekly
- The support worker's holidays or absences will not be charged



Your Commitment:

- Be punctual for all appointments
- Attend agreed sessions regularly
- Give at least 24 hours' notice if unable to attend by calling 01727-841841 during office hours (Mondays-Thursdays from 9am to 1pm) or 07582-063218 out-of-office hours.
- Give notice for holidays
- Respect our volunteers



Your Support Worker:

- Is specially trained to work with bereaved children according to Bereavement Matters' model
- Abides by Bereavement Matters' Code of Ethics and Practice
- Undergoes an enhanced DBS check
- Receives regular supervision
- Receives on-going professional training

Confidentiality

Confidentiality will be respected except in circumstances where there is danger to self and/or to others.

In accordance with the Data Protection Act 1998, all information is securely held by SABN and treated confidentially and with respect. It will be held solely for the purpose of providing support for bereaved persons. The information will not be disclosed to external agents without the express permission of the individual concerned, other than to comply with statutory or other legal requirements. To ensure that information that we hold is accurate and up-to-date, you should inform SABN of any changes. Information may be used for SABN's own promotional purposes which include our newsletter, information on our activities and fundraising. This may be done by telephone, email or post. If you do not wish your information to be used in this way, or you do not wish to be contacted by electronic means, please inform us.



You can choose to make a referral via your child's school

When a referral is made through the child's school, the SCHOOL AGREES:

- To obtain parent/carer consent
- To provide a safe, nurturing and appropriate room for the pupil to be seen by the Bereavement Support Worker which would be made available and ready to use for the agreed number of sessions
- To provide a member of staff to communicate with and make known the Safeguarding/Designated Senior Person for child protection concerns
- To inform Bereavement Matters in advance if the pupil is absent from school when a session has been planned
- To be invoiced at the end of the work
